CARBON MONOXIDE HAZARD. Burning charcoal inside without adequate ventilation can be fatal due to the evolution of carbon monoxide. Never burn in a confined space.

Wear full protective clothing and self-contained breathing apparatus.

Shut off spill, if possible, without personal risks.
