## SECTION 4 FIRST AID MEASURES

---

### FIRST AID TREATMENT

**Swallowed:** If swallowed, do NOT induce vomiting. Give a glass of water. Seek medical advice.

**Eye:** If in eyes, hold eyes open, flood with water for at least 15 minutes. Seek immediate medical assistance.

**Skin:** If skin contact occurs, remove contaminated clothing and wash skin thoroughly with water and follow by washing with soap if available. If irritation occurs seek medical advice.

**Inhaled:** Remove victim from exposure if safe to do so. If rapid recovery does not occur, transport to nearest medical facility for additional treatment. Remove contaminated clothing.

**First Aid facilities:** Potable water should be available to rinse eyes or skin. Provide eye baths and safety showers.

**Advice to Doctor:** Treat symptomatically.

**SECTION 5 FIRE FIGHTING MEASURES**

---

**Specific Hazards:** A highly flammable liquid. May form flammable vapour mixture with air. Avoid all ignition sources. Flameproof equipment necessary in area where chemical is being used. Nearby equipment must be earthed. Vapours may travel considerable distances to source of ignition and flashback. Vapours may accumulate in low or confined areas.

**Hazards from combustion products:** Carbon monoxide and/or carbon dioxide may be evolved.

**Fire Fighting Media and Instructions:** Highly flammable liquid. Heating can cause expansion or decomposition leading to violent rupture of containers. Use water fog or spray, foam, dry agent. Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to vapour or combustion products.

**SECTION 6 ACCIDENTAL RELEASE MEASURES**

---

Observe all local and national regulations.

**Spills and Disposal:** Shut off all sources of ignition. Increase ventilation. Clear area of all unprotected personnel. Stop leak if safe to do so. Absorb with dry earth, sand or other non-combustible and inert material. Use non-sparking tools. Take precautionary measure against static discharge. Ensure electrical continuity by bonding and earthing all equipment.

**Methods and Materials for Containment and Clean Up Procedures:** For small spills (<1 drum), transfer by mechanical means to a labelled, sealable container for product recovery or safe disposal. Allow any residues to evaporate or use an appropriate absorbent material and dispose of safely. For larger spills (> 1 drum), transfer by means such as a vacuum truck to a salvage tank for recovery or disposal. Retain as contaminated waste. Allow and residues to evaporate or use an appropriate absorbent material and dispose of safely.

**SECTION 7 HANDLING AND STORAGE**

---

**Precautions for Safe Handling and Storage:** Avoid breathing of or contact with material. Use in well ventilated areas. Wash thoroughly after handling. Avoid contact with skin and eyes and clothing. Handle open containers in well ventilated area. Ensure that the workplace is ventilated such that the Occupational Exposure limit is not exceeded. Do not empty into drains. Do not eat, drink or smoke in contaminated areas. Before eating, drinking or smoking, remove contaminated clothing and wash hands. Do not store near strong oxidants.

**Dispensing:** Electrostatic charges may be generated during transfer. Electrostatic discharge may cause fire. Ensure electrical continuity by earthing all equipment.

**Flammability:** Highly flammable.

**SECTION 8 EXPOSURE CONTROLS / PERSONAL PROTECTION**

**Exposure Standards:** National Occupational Health & Safety Commission (NOHSC) Worksafe Australia has set an exposure standard 720mg/m<sup>3</sup> (200ppm) TWA (8hr), STEL 1440mg/m<sup>3</sup> (400ppm).

**Biological Limit Values:** No biological limit allocated.

**Personal Protective Equipment:**

**Respiratory Protection:** If inhalation risk exists an approved organic vapour respirator (AS/NZS 1715 and 1716) should be worn.

**Hand Protection:** Use solvent resistant gloves (nitrile, PVC or neoprene).

**Eye Protection:** Wear safety goggles.

**Protective Clothing:** Use chemical resistant glove/gauntlets, boots and apron.

**Engineering Controls:** Ensure that adequate ventilation is provided. Maintain air concentrations below recommended exposure standards. Avoid generating and inhaling mists. Keep containers closed when not in use.

**HEALTH EFFECTS**

*Acute:*

**Swallowed:** Swallowing may result in nausea, vomiting and central nervous system depression. If victim shows signs of central nervous system depression (like those of drunkenness) there is a high possibility of patient breathing in vomit and causing lung damage.

**Eye:** Irritating to eyes.

**Skin:** Contact with skin may result in irritation. Will have a degreasing effect on the skin. Repeated or prolonged skin contact may lead to irritant contact dermatitis.

**Inhaled:** Breathing in vapour can produce central nervous system depression, which can lead to loss of co-ordination, impaired judgement and if exposure is prolonged, unconsciousness.
