SECTION 4 FIRST AID MEASURES

FIRST AID TREATMENT

Swallowed: If swallowed, do NOT induce vomiting. Transport to nearest medical facility for additional treatment.
Eye: If in eyes, hold eyes open, flood with water for at least 15 minutes. Seek immediate medical assistance.
Skin: If skin contact occurs, remove contaminated clothing and wash skin thoroughly with water and follow by washing with soap if available. Seek immediate medical assistance if irritation occurs.
Inhaled: Remove victim from exposure if safe to do so. If rapid recovery does not occur, transport to nearest medical facility for additional treatment. Remove contaminated clothing.

First Aid facilities: Potable water should be available to rinse eyes or skin. Provide eye baths and safety showers.

Advice to Doctor: Treat symptomatically.

SECTION 5 FIRE FIGHTING MEASURES

Specific Hazards: Flammable liquid.

SECTION 6 ACCIDENTAL RELEASE MEASURES

Observe all local and national regulations.

Spills and Disposal: Shut off all sources of ignition. Increase ventilation. Clear area of all unprotected personnel. Stop leak if safe to do so. Absorb with dry earth, sand or other non-combustible and inert material. Collect and seal improperly labelled containers or drums for disposal. Wash down area with excess water.

SECTION 7 HANDLING AND STORAGE

Precautions for Safe Handling and Storage: Avoid breathing of or contact with material. Use in well ventilated areas. Wash thoroughly after handling. Avoid contact with skin and eyes and clothing. Handle open containers in well ventilated area. Ensure that the workplace is ventilated such that the Occupational Exposure limit is not exceeded. Do not empty into drains. Do not eat, drink or smoke in contaminated areas. Before eating, drinking or smoking, remove contaminated clothing and wash hands. Do not store near strong oxidants, copper and natural rubber.

Flammability: Flammable.

SECTION 8 EXPOSURE CONTROLS / PERSONAL PROTECTION

Exposure Standards: Worksafe Australia has set an exposure standard 274mg/m³ (50ppm) TWA (8hr), STEL 548mg/m³ (100ppm).

Biological Limit Values: No biological limit allocated.

Personal Protective Equipment:

Respiratory Protection: If inhalation risk exists an approved organic vapour respirator (AS/NZS 1715 and 1716) should be worn.

Hand Protection: Use solvent resistant gloves (nitrile, PVC or neoprene).

Eye Protection: Wear safety goggles.

Protective Clothing: Use chemical resistant glove/gauntlets, boots and apron. Skin protection not ordinarily required beyond standard issue work clothes.

Engineering Controls: Ensure that adequate ventilation is provided. Maintain air concentrations below recommended exposure standards. Avoid generating and inhaling mists. Keep containers closed when not in use.
