Description of necessary first aid measures

Inhalation:	Keep victim calm and remove to fresh air if safe to do so. If rapid recovery does not occur, seek medical attention
Skin Contact:	If skin contact occurs, remove contaminated clothing and wash skin thoroughly with water and follow by washing with soap if available. If irritation occurs, seek medical attention
Eye Contact:	If in eyes, hold eyes open, flood with water for at least 15 minutes. If irritation occurs, seek medical attention
Ingestion:	If swallowed, do NOT induce vomiting. Have conscious person drink several glasses of water or milk. Seek medical attention if symptoms occur

Suitable extinguishing equipment

SECTION 6 ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures

Combustible liquid. Avoid contact with spilled or released material. Shut off leaks, if possible without personal risks. Isolate hazard area and deny entry to unnecessary or unprotected personnel. Remove all sources of ignition in the surrounding area. Ventilate contaminated area thoroughly.

Environmental precautions

Use appropriate containment to avoid environmental contamination. Prevent from spreading and entering waterways using sand, earth or other appropriate barriers.

Methods and materials for containment and cleaning up

For small spills (< 1 drum), dilute with water and mop up, or absorb with an inert dry material and place in an appropriate waste disposal container.

For larger spills (> 1 drum), transfer by means such as a vacuum truck to a salvage tank for recovery or appropriate disposal.

Allow any residues to evaporate or use an appropriate absorbent material and dispose of safely in accordance with regional regulations.

Precautions for safe handling

Avoid breathing vapours. Do NOT ingest. Avoid contact with skin, eyes and clothing. Wash thoroughly after handling. Do not eat, drink or smoke in contaminated areas. Handle and open containers with care in a well-ventilated area. Ensure that the workplace is well ventilated. Do not empty into drains.

Conditions for safe storage, including any incompatibilities

Store in a cool, well-ventilated area, away from sunlight, ignition sources and other sources of heat. Do not store near strong oxidising agents.
